Your Retirement Outlook will appear at the top of the overview page so you can quickly review your forecast.

Improving your forecast

If there are a few clouds in your forecast, it's easy to make adjustments to help you get sunny:

- Click **CHANGE OUTLOOK** on the overview page to increase your contribution rate
- Add any outside retirement account assets for a more accurate picture — including accounts your spouse or partner hold. To do this, hover over **Investments** in the top navigation bar and select **Retirement Incomes** under **Are You OnTrack®?**
- Consider changing your goals

As a general rule, you'll need **75%** to **80%** of your salary to maintain your lifestyle in retirement. That means if your final salary is \$55,000, you'd need about \$44,000 annually in retirement.

Other forecast factors


In addition to the information you provide, *Your Retirement Outlook* is based on other factors that help create a more accurate forecast:

(with inflation assumptions)


 **Life expectancy**
